



Project Summary:

Small Business Act - Strategic and Policy Framework in BiH (SBA in BiH)





Problem

Failures of former and present efforts to harmonise legal, strategic and policy framework for SMEs in BiH could have several interconnected causes: an approach that was not suited to the problem context (top-down approach in a context of very decentralised responsibilities for SMEs); a strong orientation on international expertise in a complex situation; dominant use of public sector perspective; and a lack of common methodological framework that could be acceptable for all key stakeholders and used in all phases of policy/strategy development.

Consequences includes: very fragmented and reduced international and donors assistance (as the main source of financial and technical support to SME development in BiH); significantly reduced impact of local efforts and resources invested in SME support; failure to consider perspective of SMEs and improvement of their performances; and constantly repeated lack of progress regarding SME policies in Annual BiH Progress reports prepared by the European Commission.

Main Idea

To use and adapt Small Business Act (and SME Policy Index) as a common methodological framework to harmonise legal, strategic and policy framework for SMEs in BiH, by encompassing all stages of policy development (planning, implementation, M&E, revision) and facilitating interactions of key stakeholders.

Overall Objective

Support institutions in BiH to accelerate economic integration with the EU in the field of SME strategic and policy framework, with higher impact on performances of SMEs in the country.

Specific Objective with Expected Results

Harmonised legal, strategic and policy framework for SMEs in BiH based on Small Business Act (SBA) as the main guideline for Western Balkans countries, gradually achieving:

- 1. Improved implementation of SME focused strategies and plans, focused on projects/policies related to SBA (Strategy Implementation Enabling Mechanism);
- 2. Common methodology for planning, implementation, M&E and revision of SME focused strategies and plans in BiH (based on SBA and SME Policy Index);
- 3. Revision of current and planning of new strategies and policies for SME development by applying the common methodology;
- 4. Harmonisation of laws related to SME in both entities and Brcko District;
- 5. Public-private dialogue being institutionalised as a tool to support SME development at all administrative levels in BiH;
- 6. Development and promotion of harmonised policies and practices aimed to SME development.

A minimum of activities to achieve these results is elaborated in the project proposal. Key method is facilitation.

Timeline

August 1, 2017 - December 31, 2021

Phases and Focuses

1. phase: August 1, 2017 - July 31, 2018

Support to improved implementation of SME focused strategies and plans; harmonisation of legal framework with SBA; development of the first (conceptual) part of common methodology for planning, implementation, M&E and revision of SME focused strategies and plans.

2. phase: August 1, 2018 - July 31, 2019

Support to improved implementation of SME focused strategies and plans (continuation); development of practical part of common methodology for planning, implementation, M&E and revision of SME focused strategies and plans; revision of current SME focused strategies and plans.

3. phase: August 1, 2019 - July 31, 2020

Support to improved implementation of SME focused strategies and plans (continuation); development of new SME focused strategies and plans (2021-2027) based on common methodology for planning, implementation, M&E and revision; development of harmonised policies and practices aimed to SME development; promotion, institutionalisation and strengthening public-private dialogue at all levels.

4. phase: August 1, 2020 - December 31, 2021

Ensuring sustainability of Strategy Implementation Enabling Mechanism; finalisation and promotion of new SME focused strategies and plans (2021-2027); finalisation and promotion of harmonised policies and practices aimed to SME development; support to improved functioning of public-private dialogue.


