Specific and general project objectives:

General Objective:

Improve the implementation of strategies and plans to support the implementation of energy transition projects (increase in energy efficiency and use of renewable energy and introduction of energy management practices) of manufacturing small and medium-sized enterprises (SMEs) in BiH.

Specific Objectives:

- Implemented and evaluated a systemic approach to supporting SMEs in selected industrial sectors under conditions in BiH,
- Established at least one network of SMEs for the exchange of information and experiences in the implementation of energy transition projects.

Key activities:

- Conducting preliminary energy efficiency audits (in at least 15 SMEs) from defined geographical areas and relevant industrial sectors,
- Development of project and financial documentation required for applying to financial support funds (in at least 5 SMEs),
- Creation of a database and know-how about standardized energy transition measures (at least 5 measures),
- Elaboration of the methodology for the preparation, introduction and audit of the energy management system and its testing for the acquisition of ISO 50001 ready/light status (without certification) in at least 5 SMEs,
- Development of a methodology for establishing an energy transition network (ETN) and its implementation for a pilot (regional) network, which includes at least 10 SMEs,
- Elaboration and dissemination of guidelines for financing the energy transition in SMEs in BiH,
- Defining at least 3 proposals for improving public policies for energy transition in SMEs,
- Organizing at least one conference in order to promote a developed approach to support the energy transition in SMEs,
- Organizing at least one study visit in one of the EU countries,
- Organization of the final conference and media promotion of the project.

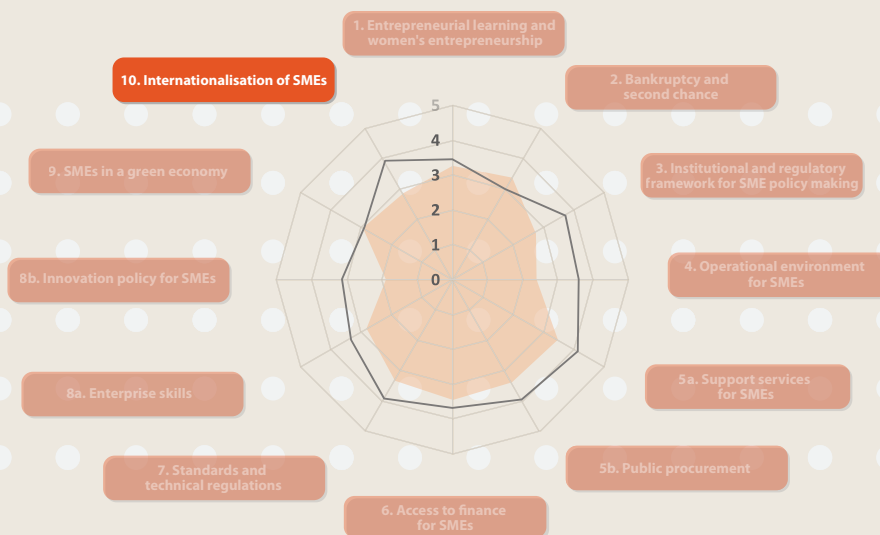

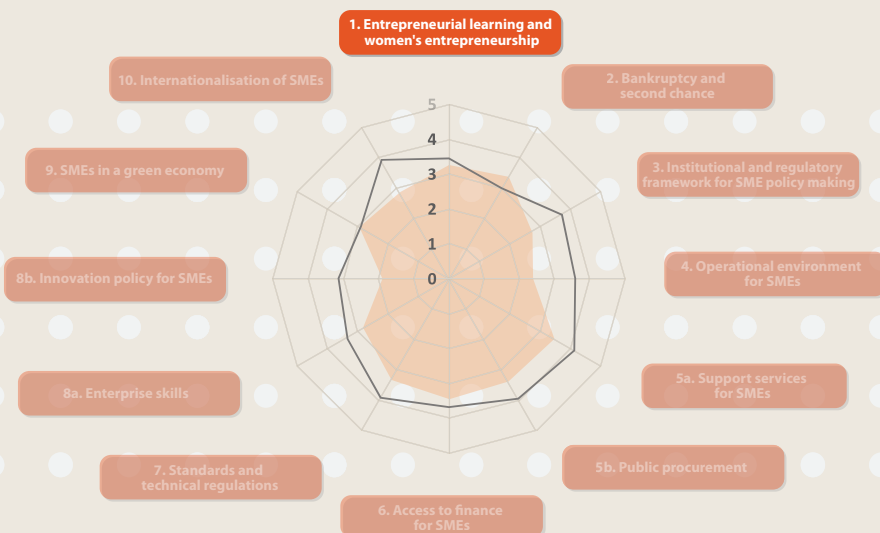
